Refunds & Deferrals

Refund policy - 60 days

Absolutely no requests after: August 11th, 2020

Registered runners may request a full-refund of their paid fee up to 60 days prior to the event. No refunds will be granted in the final 60 days before the event. Please contact us about refunds at hi@boulderthon.org.

Registration Transfers - 14 Days

Absolutely no requests after: September 27th, 2020

A request must be sent no later than two weeks prior to the event by the runner who purchased the registration with the name, address, email, gender and date of birth of the runner taking their place to hi@boulderthon.org. A registration transfer processing fee of \$25 will be incurred.

Deferrals - 7 Days

Absolutely no requests after: October 1st, 2020

A deferred registration is \$40. Those who request to defer to the following event year will be provided with a registration link and instructed to register within one week of receiving the deferral link. Upon receiving a confirmation email after registering the deferral, they will be registered for the coming year’s event and it will require no further action.
